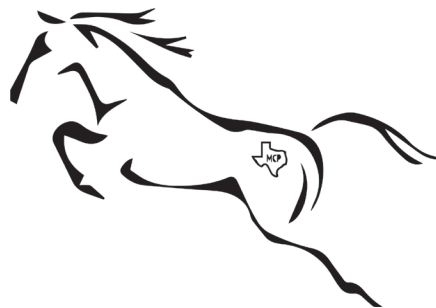
WARNING:
